Once the wild and unruly "Tessa" had managed to get through her basic obedience training and achieved her CD, an additional recreational outlet was needed for this energetic little dog! That led Pam to a beginner Agility class, and the start of her love for the sport of Dog Agility. After many years of training and competing in the show jumping and dressage world with horses, working with dogs in Agility has seemed a natural progression.</i></p> <p><i>Having had the good fortune to be able to train for several years with Kathie Leggett in Sacramento, CA, Pam began teaching agility classes at her own facility, Maple Leaf Training, in Sparks, Nevada. Her Shetland Sheepdog, Petey, has his ADCH and has twice won first place in Agility at the Sheltie Nationals. He was the first place winner of the Western Regional of Purina's Incredible Dog Challenge and has been a Finalist in Steeplechase and Grand Prix at the USDAA Nationals. Shetland Sheepdog, Puff, has her MACH and her ADCH. She was the Purina Incredible Dog Challenge National Champion in 2003, competed in ESPN's Great Outdoors Games, and has been a USDAA Nationals Finalist four times.</i></p> <p><i>The newest agility competitor at the Richcreek home is a Golden Retriever, Allie, who has her AX & MXJ titles. All three dogs competed in the Canadian Agility National Finals in 2005, Allie's first year of competition.</i></p> <p><i>Pam's husband, Craig, retired two years ago and the family moved from Nevada to McKinney, TX where they are enjoying life with their 5 dogs and a cat. Pam continues to compete with her dogs and is an Agility Judge for AKC, USDAA and CPE.</i></p>
